Formerly he was Singapore Ambassador to Indonesia.

Professor Xue Li

Prof Xue Li is Director of the Department of International Strategy, Institute of World Economics and Politics, Chinese Academy of Social Sciences (CASS) in Beijing. Current research interests include China's foreign policy, particularly in relation to One Belt One Road and South China Sea issues.

Mr. Christopher Elder

Christopher Elder is Senior Fellow in the New Zealand Contemporary China Research Centre at Victoria University of Wellington.

Formerly he was New Zealand Ambassador in four key countries: China, Indonesia, Russia and Germany. He also held positions in the New Zealand Ministry of Foreign Affairs and Trade including Deputy Secretary for Asian affairs and security policy
